Nevada Libraries Specialty License Plate Update



State Librarian Sara Jones led an initiative, with the assistance of NLA, to request a Specialty License Plate for Nevada Libraries. The request was submitted to the Department of Motor Vehicles with over 1500 signatures in September. On October 18th, Thomas Felton, Tom Fay, Holly Van Valkenburgh and Sharon Hoenig-Bear went before the Commission on Special License Plates to provide testimony on the merits of a license plate for Nevada Libraries. We are proud to announce that the Commission recommended to the DMV that the Nevada Libraries plate be the first produced.

Now the License Plate won't go into production until the Fall of 2005, but NLA and the State Library would like to thank all of those who put forward so much effort on this initiative. We will continue to update you on the status of this effort.

It Was A Very Good Conference - Financially Speaking

The 2004 NLA Annual Conference, held this year at Lake Las Vegas from August 11-14, is now history. From all reports the conference, under the able leadership of Joan Vaughan, was a smashing success in a number of ways including quality programs and excellent exhibits. My job is to report on the financial performance of the conference.

Income generated by the conference totaled \$87,800. Exhibitor Booth Registration was the largest source of revenue (\$43,800) and accounted for 50% of the total revenue. Personal Registration (excluding meal functions which are a pass-thru) was the second largest source of revenue (\$21,500) followed by Donations/Grants (\$13,400).

Conference expenses totaled \$55,850. Facility expense (exhibit hall rental and setup, AV, telco, etc.) was the largest expense category (\$21,300) followed by program/speaker expenses (\$14,650). The third largest expense category was publicity/printing/postage/supplies (\$6,500).

Conference income in excess of expense was \$31,950 (\$87,800 minus \$55,850) making this Las Vegas conference even more financially successful than the very successful joint conference last year with MPLA which netted NLA \$30,625.

The NLA Treasurer salutes Joan Vaughan and the entire Conference Committee for a job well done!

- Planning and implementation of academic/research library programs in women's studies disciplines of such exemplary quality that they could serve as a model for others.

Nevada Library Association 2004 Annual Report of the Recording Secretary

The Board of Trustees of the Nevada Library Association held two formal meetings this year. Between these meetings, the business of the Association was carried out by e-mail, telephone calls, and mail.

The Board of Trustees of the Nevada Library Association met on January 21, 2004, at the West Las Vegas Library (Las Vegas-Clark County Library District). Nine voting members of the Board and thirteen advisory members and guests attended. In Old Business, the Board discussed the Nevada Library Association Strategic Plan, payment of honoraria to instate members of the association, and testing membership database management software. In New Business, the Board received budget requests from chairs or representatives of sections, interest groups, delegates to other organizations, appointed officers, and standing and ad hoc committees and subsequently passed a comprehensive budget for association work. Finally, the Board heard reports on planning for upcoming conferences. Minutes of this meeting, including exhibits, are on file with the Executive Secretary of the Association.

The second meeting of the Board of Trustees Board would ordinarily be held during the Nevada Library Association conference in October. Because the conference was held in August and nominations for NLA officers are presented at an October business meeting, the business meeting was deferred until October 26th, 2004.

The Board of Trustees of the Nevada Library Association met October 26, 2004, at the Clark County Library (Las Vegas-Clark County Library District). Six voting members of the Board and fifteen advisory members and guests attended.

In Old Business, the Board discussed progress on developing the Nevada Library Association Strategic Plan, noting that the afternoon session would be devoted to furthering the process. The Board heard a report on recent use of a memberships database and association management software package and a report on the Gold Pin Leadership Program. In addition the board reconsidered providing honoraria to in-state members when they provide programs at the association conference. By unanimous voice vote, the Board of Trustees declined to change existing policy.

In New Business, the Board heard reports on a library marketing program available to the association, the recent MPLA/Colorado Association of Libraries meeting in Denver, and the availability of a Nevada Libraries custom license plate. The Board also heard a report about conflicts between the MPLA and NLA Bylaws as to the term of office for the MPLA delegate. In addition, the Board accepted the report of the Nominating Committee and heard nominations from the floor for 2005 NLA officers. Finally, the Board discussed planning for future NLA conferences.

In the afternoon session, members of the Board of Trustees and interested advisory members and general association members divided into groups to work on goals, objectives and actions for the Nevada Library Association Strategic Plan. Groups were asked to continue their work as needed and to be prepared to present working papers at the next Board of Trustees meeting, which will be held in January 2005 in the Reno area. Minutes of these meetings, including exhibits, are on file with the Executive Secretary of the Association.

Nevada State Library and Archives Continuing Education Advisory Task Force

"Advances in information technology and expanding library user expectations require continuous education. Nevada libraries are committed to addressing the need for continuous library education through planned, coordinated and varied statewide continuing education programs to hone staff expertise, foster professional development, empower library trustees, broaden public awareness and ultimately improve library services."

The above paragraph is the Nevada Continuing Education Mission Statement in the Nevada Libraries Continuing Education Plan, 2002, which can be found at http://dmla.clan.lib.nv.us/docs/nsla/lpd/conted/

As part of the overall strategic planning process of the Nevada State Library and Archives (NSLA), a task force has been created in which the members will participate in the assessment of the continuing education (CE) needs of library staff and trustees within Nevada.

The Task Force will first meet November 30, 2004, at the South Valleys Library in Reno. Karen Starr, Assistant Administrator for Library & Archives Development at NSLA will be the facilitator of the planning process. Karen has come to NSLA with expertise in effective meeting management techniques and collaborative problem solving.

The CE Advisory Task Force will work with NSLA staff to develop a new three-year (2005-2008) strategic planning document for statewide continuing education addressing the needs of all types of libraries in the state. The Task Force will collaborate in the development of a process of effective planning and communication among the key library continuing education stakeholders.

During the planning process, the Task Force will work with those stakeholders to identify mandates which drive continuing education

needs. It will assess current CE activities, patterns, and potentials in Nevada. Task Force members will investigate other Nevada statewide and regional CE activities to develop a vision, strategic issues, goals, and activities for statewide continuing education in Nevada.

The Task Force will participate in regional focus groups in Nevada to develop buy-in from the library community and collaborate with the Nevada Library Association and its Board in its Association planning process.

The NSLA website and the Nevada Library Association (NLA) listserv will be used to disseminate planning information and meeting records. The final planning document will be submitted to the Nevada State Librarian for review and acceptance and through her to the Nevada State Council on Libraries and Literacy for endorsement. The document will also be submitted to the Nevada Library Association Board for endorsement. Upon acceptance and endorsement, the document will be published on the NSLA website. Identified implementation projects will be prioritized and decisions will be made by NSLA staff regarding actual implementation.

Task Force members are Tammy Gieseking (Las Vegas-Clark County Library District), Theresa Kenneston (Washoe County Library System), Barbara Mathews (Churchill County Library), Danna Sturm (Western Nevada Community College), Susie Skarl (University of Nevada, Las Vegas), Mona Reno (Nevada State Library & Archives), Ellen Fockler (Washoe County School District), Gregory Robinson (Nevada State College and NLA Personnel Development) and Reed Scull (University of Nevada, Reno). Please contact any of them individually if you have input for this endeavor.

The University of Nevada, Reno's Extended Studies unit is in its eleventh year of offering courses that help public and school librarians and library paraprofessionals meet their certification and other professional development requirements. In the Spring of 2005, three courses will be available.

A one-credit course will be offered through UNR Extended Studies that will meet in Carson City at the Nevada State Library & Archives (NSLA) building on two Saturdays (March 19 and April 30). HP 499/699 Special Topics: Historical Treasures of Nevada— Nevada Political Leaders and Movements, will examine Nevada's colorful political history through an examination of documents/artifacts in the Nevada State Archives. Each item examined will be discussed towards developing an appreciation for the preservation of historic documents and artifacts. Students will conduct their own research that will provide them with insights on how research in a government archives can be done. The instructor is Jeff Kintop, the State Archives Manager at the NSLA.

This course could be of interest to a variety of students of the liberal arts, as well as K-12 teachers seeking to enliven their social studies curricula and persons generally interested in Nevada's rich heritage. UNLV SELECTS NEW DEAN OF LIBRARIES

Iannuzzi Recognized Nationally as a Leader in Creating Partnerships That Integrate Information Literacy Into Teaching and Learning

Patricia Iannuzzi, Associate University Librarian at the University of California, Berkeley, has been named Dean of Libraries at UNLV, effective February 7. Iannuzzi currently serves as the director of the Doe and Moffitt Libraries and interim director of collections at the University of California, Berkeley, where she has been since 2000. She has served on the Presidential Committee on Information Literacy Partnerships for the American Library Association, and has presented papers on various topics pertaining to the library's role in undergraduate education. In addition, she co-designed and co-facilitated two evaluation workshops, sponsored by the Andrew W. Mellon Foundation.

"Patricia understands the central role of information literacy in the learning environment and how to mobilize faculty and staff to enhance the educational experience," said UNLV Executive Vice President and Provost Ray Alden. "Clearly, she will advance UNLV's model of a student-focused, research university."

Iannuzzi earned a bachelor's degree in psychology from Yale University in 1976, and later went on to receive a master's degree from the Simmons College Graduate School of Library and Information Science in 1981.

"I am looking forward to being part of another dynamic and innovative organization that is committed to the balance between teaching and research," said Iannuzzi, who brings 20 years of experience to the position. "UNLV shows that it is eager to explore innovations and embrace change to meet the challenges of a contemporary urban university."

The Dean of Libraries at UNLV oversees all libraries on campus, including the Lied, Curriculum Materials, Music, and Architecture Studies libraries.

Book Repair Workshops

Three Book Repair Workshops will be offered in the new Conservation Laboratory at NSLA in mid-February, March and April, 2005. They will be provided through NSLA's Continuing Education program, at no cost to participants.

Nevada's membership in the Bibliographical Center for Research (BCR) qualifies us for this superior training being presented by Amigos Library Services.

Basic Book Repair (2 day) February 15 -16

This two-day course is designed to provide information and hands-on experience in basic book and paper repair for general (non-rare) library collections. Participants learn about treatment decisions, repair options, and supplies. They will practice a variety of repair techniques in the supervised, hands-on portions of the workshop. Topics and techniques covered include surface cleaning and paper repair, attaching loose pages, book structure, paperback reinforcement, endsheet replacement, enclosures, workflow, and selecting supplies and equipment

Intermediate Book Repair March 15-16

Formerly "Advanced Book Repair"

This two-day course was developed as a follow-up to Basic Book Repair and covers more complex repairs to books and paper. Participants should have completed Basic Book Repair before enrolling in this course. Techniques and topics covered include complex paper repair, spine replacement, corner repair, enclosures, sewing in loose signatures, recasing a book in its original cover, plus a review of decision-making, workflow, and how to set up a repair unit. How to identify items requiring the expertise of a conservator and how to make decisions for special collection items are also discussed.

Advanced Book Repair (2-day) April 12-13

This two-day workshop covers advanced repairs to books. Participants should have completed both Basic Book Repair and Intermediate Book Repair before enrolling in this course, and be confident in their hand skills. Topics and techniques covered include the history of papermaking and bookbinding, sewing an endsheet, re-sewing a broken textblock, how to repair foldouts in books, flattening rolled or folded items, spine replacement (a different technique from that covered in Intermediate Book Repair), enclosures, and identification of materials appropriate for a trained conservator. The course will conclude with a final review of book repair options, decision-making, and summarization of topics covered in all three workshops.


Incline Village

Attendees at 2005 Pre-Midwinter Institute will build advocacy skills, develop public awareness strategies

CHICAGO - Register today for the American Library Association's (ALA) 2005 Advocacy Institute planned for January 14 during the ALA Midwinter Meeting in Boston. Attendees at the daylong Institute will build advocacy skills and develop new strategies for raising awareness of the value of libraries in today's society.

"Ensuring that everyone understands the value of libraries in our society is critical to the very survival of libraries," said Carol Brey-Casiano, president, ALA. "This Institute will build new coalitions of library advocates who have a plan for communicating the important role of libraries in a democracy and the skills for putting it into action."

The 2005 Advocacy Institute opens an ALA Midwinter Meeting that is focused on issues of library advocacy, including the President's Program Speech by Malcolm Gladwell, author of "The Tipping Point: How Little Things Can Make a Big Difference." Gladwell's book examines why major societal changes often happen suddenly and unexpectedly.

Institute attendees will form teams of library staff members, trustees and friends and leave the workshop with a draft of an advocacy action plan for their library community. Following the Institute, participants will receive information and support through email listservs and a new Web site devoted to library advocacy issues, materials and success stories.

Registration will begin at 9 a.m. with a keynote address

from Massachusetts Lieutenant Governor and library advocate Kerry Healey scheduled for 9:45 am. A member of the Friends of the Library in her local community of Beverly, Mass., Healey successfully cochaired the campaign to rebuild her city's library, raising more than \$1 million in private funds and grants.

Attendees will learn about strategies for message development and available resources for developing action plans for their communities. Working in teams, attendees will develop their advocacy plans supported by presentations from library advocacy leaders such as ALA Public Awareness Committee Chair and Friends of Libraries USA (FOLUSA) Executive Director Sally Reed and Glenn Miller, executive director, Pennsylvania Library Association.

While all types of libraries struggle with similar issues, the first Institute is designed to develop public library advocates. Future institutes will address the unique needs and issues of school and academic libraries as well as other specialized groups.

The Nevada Supreme Court Law Library and Volunteer Attorneys for Rural Nevadans (VARN) have developed a "Lawyer in the Library" program, to help inform and educate the public at large on a variety of legal issues, including divorce, child custody/child support, consumer law, bankruptcy, probate, wills and more. The goal of the "Lawyer in the Library" program is to educate and equip lay people to address common legal issues and/or function within our legal system.

Licensed Nevada attorneys have volunteered to help members of this community effectively address certain legal issues and/or participate in our legal system. The volunteer will try to provide you with background on your legal issue, help you identify what you might do to address that issue and may point out materials that specifically discuss and explain your issue. The volunteer can also provide you with references to a number of legal services that may be able to offer more detailed assistance.

Initially, the Lawyer in the Library program will be held once a month at the Nevada Supreme Court Law Library, 201 S. Carson Street, Carson City, Nevada, from 5:30 p.m. to 7:00 p.m. The next Lawyer in the Library program is scheduled for January 19, 2005. Appointments will be scheduled for interested participants to meet with a volunteer attorney for approximately 10-15 minutes.
