



The Final Report on the Functional Requirements for Bibliographic Records (FRBR) has been the subject of much discussion in the library world since it was released in 1998. As a proposed model for bibliographic data it has been utilized by the Joint Steering Committee for Development of RDA (JSC) in preparing Resource Description and Access (RDA), the cataloging rules planned to replace AACR2 (Anglo-American Cataloging Rules, 2nd ed.). Local system vendors and organizations such as the Library of Congress and OCLC are investigating how FRBR might influence the structures of library catalogs. ### **License Plate Report**

Thanks to all who pulled the License Plate Report together for delivery to the Legislative Counsel Bureau. To date, we haven't spent any of the money derived from the sale of the license plate, although it has been accumulating since July 2005. It is critical that we do what we promised to do in this document and that we can report next year at this time that we have completed those projects.


License plate renewals generate about \$10,000 per year, which is very real money to NLA. I do think it will dwindle as time goes by and people do not renew their license plates, but it will be many years before this revenue ceases to come in as long as we comply with the requirements.

To date, the NLA has been accumulating License plate funding with the intention of aggregating sufficient resources to support the following purposes, which are specific to the intent of the license plate application. According to the methods and procedures approved by the NLA Executive Board in January of 2008, the funds are to be distributed as follows:

- 40% Summer Reading Program, to benefit children statewide
- 40% Scholarships to support the continuing education of librarians\*
- 20% Scholarship fundraising to support the education of librarians\*

From inception of the project through the calendar year 2007, the License Plate project produced revenue of \$26,570.50. The NLA Board met on August 13, 2008 and outlined the following expenditures:

- 40% (\$10,628.20) in support of the statewide Summer Reading Program will fund "kits" to promote reading, and will be provided to each library system in the state in time for Summer 2009 Reading Programs.
- 40% (\$10,628.20) will provide two (2) \$5,000 scholarships to Nevada students who commit to become librarians in Nevada.
- 20% (\$5314.10) will provide the basis for a fundraising event with proceeds to be dedicated to additional scholarships. A fundraising event will be planned for the 2009 Elko NLA conference, with the goal of funding two (2) \$5,000 scholarships to Nevada students committing to be librarians in Nevada.
- \* The average cost of attending library school to obtain a Masters' degree in library science is \$30,000.

As this was my second year as NLA delegate to MPLA, I was a little more organized with my duties!

I submitted a budget for 2008 and attended the midwinter board meeting of NLA Trustees on January 15<sup>th</sup>. The meeting was held at the West Charleston Library in Las Vegas.

I advertised the Utah Library Association/MPLA Annual Conference (which was held during April 29-May 2, 2008) by sending e-mail and flyers to Nevada librarians and libraries. I attended the conference and presented a report on NLA during the annual meeting of the MPLA Board in Salt Lake City.

Every three months I reported on Nevada library activities to the MPLA Executive Board. Two of these reports are presented in-person, one at the joint annual conference and one at the MPLA Executive Board's annual meeting in Denver. During the year, I also participated in 3 conference call meetings with the MPLA Executive Board.

I submitted 2 articles to the editor of <u>Nevada Libraries</u>, and wrote an article for publication in the <u>MPLA Newsletter</u> every two months.

On March 25<sup>th</sup>, I met with the rest of the NLA Conference Committee at the Santa Fe Station to tour the convention area and plan for the conference. I am serving as Chair of the Registration Committee for the Conference.

### Nevada Young Readers' Award Committee 2008 Annual Report

#### **Accomplishments**

#### **Budget**

Perma-Bound is again our sponsor for the thirteenth year. We greatly appreciate the help that they have been in working with us to secure authors and books for the NYRA breakfast this year, especially considering the difficulty we have had in getting any authors to come in such a short space of time.

#### **March Meeting**

The March meeting was held via teleconferencing and rooms were again supplied by the University of Nevada. Scheduling the meeting was again challenging because of different Spring Break schedules throughout the state.

Attendance was down across the board, most notably in the Young Adult and Intermediate Reader Categories, which had extra long reading lists this year. Though this may have more to do with conflicting Spring Breaks, we hope to next year have a larger turnout. The email list for NYRA consists of 100+ contacts, but not even close to that many attended the meeting, or even submitted votes via email. We have started GoodReads interest groups at www.Goodreads.com in an effort to jumpstart discussion online.

Overall, though, the meeting went very well. There was some lively discussion and we selected this next year's final reading list with even more efficiency than we have in the past.

#### Voting

2008's NYRA winners are:

Picture Book: <u>Sweet Tooth</u> by Margie Palatini Young Reader: <u>Ghost's Grave</u> by Peg Kehret

Intermediate: Magyk by Angie Sage Young Adult: Uglies by Scott Westerfield

We had 45,154 votes this year from 107 schools all over the state. (We also had some late votes that brought our total to 45, 820 votes. These extra votes did not change the outcome.)

#### Recommendations

It is recommended that all documents relating to NYRA be collected electronically and posted to the NYRA website to ease in the transition process. This includes the NYRA recommendation form, lists of important contacts for the March meeting and Permabound, a timeline, and any other pertinent information that will make things much easier for the incoming chair(s). Hopefully this will alleviate some of the problems that the 2008 chairs experienced.

It is also recommended that if the NLA Annual Conference is held again in August that the NYRA breakfast be postponed until October. This is for two reasons: 1.) It is nearly impossible to book authors for the awards ceremony in August given that the voting for the award ends on May 15th and 2.) It will be less difficult to get students to attend the awards ceremony if they are not all on vacation. It is further recommended that if no winning authors are able to attend the breakfast, regardless of when it is held, that the breakfast be postponed until a later date. For the first time ever *none* of our winning authors were able to come, leaving the chairs with some uncharted territory and very stressful working environments. As the breakfast is not mentioned at all in any of the NYRA bylaws this should not be a problem.

Many thanks to our webmaster Joan Vaughan who has been very patient about all of the reading list updates we have been sending her and to J-Lynn Van Pelt and Terry Debarger for moderating our GoodReads discussions and getting NYRA groups set up on the site.

Kids need to nominate the new books they are reading! November 15th of each year is the deadline for books that will be voted on 18 months later. The copyright date of the nominated books needs to be within the last three years. #### **READ & REVIEW NOMINATED BOOKS!**

We have four levels of books for NYRA and we need readers! The students in Nevada typically nominate around 60 books in each category each year. That list is then read by adult volunteers: teachers, librarians, & parents, from all over Nevada. The list is kept on the website listed above and updated throughout the year. We also have groups for each category at <a href="http://www.goodreads.com/">http://www.goodreads.com/</a> to provide a statewide format for discussion about the nominated books. Finally we meet in March to narrow the nominations - we decide which books will be the finalists that the kids vote from; eight finalists for the Picture Book category and six finalists for Young Reader, Intermediate, & Young Adult categories.

### ENCOURAGE KIDS TO VOTE!

After the finalists are announced in March, students have until May 15 of the following year to read half of the books on a list and vote for their favorites. Both voting forms and contact information can be found on the NYRA website listed above. This year we had over 45,000 votes from all over Nevada!

### **Publicity Committee** 2008 Annual Report

#### **Nevada Library Association**

#### Overview

The Publicity Committee created a revised NLA brochure which aims to promote membership and raise visibility by detailing membership benefits and organization information.

In 2008, the committee, through our subscription to Nevada News Service, helped produce three library-related news articles that aired on radio stations statewide. Links to websites with audio versions of these articles were added to the NLA website.

#### Detail

Following the mid-winter NLA Board meeting, the Publicity committee was charged by NLA President Denise Gerdes to create a new informational brochure. The goals of the brochure were to 1) increase membership and 2) detail the organization's purpose. With input and feedback from the committee and Denise Gerdes, we created a full-color brochure that addresses these goals. The brochure also directs potential members to the NLA website for registration and information.

Recently produced news article topics include virtual homework help, El día de los niňos/ El día de los libros (Children's Book Day), and Summer Reading Club. On average, each news article has been aired on 22 unique radio stations statewide. Articles have been picked up by stations in Reno (KBUL, KKOH, KNEV) and Las Vegas (KJUL, KMZQ, KLAV), as well as by Clear Channel, which owns stations across the state.

#### Comment

Pending approval from the Board, we anticipate the brochure will raise visibility of our organization, attract new members, and direct them to our website.

Subscribing to Nevada News Service allows NLA to promote our libraries in a time and cost effective manner across the state. These news items raise visibility in the community, build strong support among constituencies, and help to initiate and strengthen relationships with new donors, members, and the general public. This article-generating format gives rural and underrepresented libraries in Nevada a voice, as we have major input in which programs, events, and contacts are featured in an article.

The Publicity Committee will continue to raise visibility of NLA and library issues through revised publications and its work with Nevada News Service.

### Scholarships For NLA Members Seeking MLIS Degree

The James S. McPhee Memorial Scholarship fund was created to provide financial support for members in good standing of the Nevada Library Association who are seeking educational opportunities in library science. Applicants are eligible for one NLA scholarship per year, with a maximum of two awards. The NLA Scholarship award grants up to \$5000 in support of graduate course work in an American Library Association accredited library science school.

Scholarship monies in this round of awards must be used to pay tuition and course-related textbook expenses for course work taken in the summer 2008 and 2008-2009 academic years only. Reimbursement information and procedures will be provided to recipients with their scholarship notification letter. A reimbursement check payable to the awardees will be sent upon verification of tuition and textbook purchases.

Scholarship recipients will be notified in early fall 2008. Non-recipients will be notified simultaneously.
