MPLA Leadership Institute

The week-long MPLA Leadership Institute, May 6th through May 11th, will take place in beautiful Estes Park, Colorado, at the YMCA of the Sierra, with thirty participants and five mentors. The Institute is sponsored by the Mountain Plains Library Association with support from the Gerald M. Kline Family Foundation. This year's Institute will be facilitated by organizational development consultant Maureen Sullivan, 2012-2013 President of ALA, who will lead all thirty men and women through six days of intense activities, discussion, and reflection built around principles of leadership, communication, project management, commitment, and personal planning.

Nevada's two candidates for leadership are Arlene Caruso, Assistant Branch Manager/Head of Adult Services, Paseo Verde Library, Henderson Libraries, Henderson, NV; and John Crockett, Internet Services Librarian, Washoe County Library System, Reno, NV.



Arlene Caruso actually laid the foundation for her career in libraries as a high school student, although it wasn't entirely voluntary, as she found it a way to pay off some accumulated library fines. Years later, with a degree in Information Systems and an MLIS, she moved to Las Vegas. During her years as Head of Adult Services in Henderson, she's instituted and coordinated a number of original programs; a monthly Foreign Film series and the monthly READ Local Authors series are only two examples. Arlene has been active in NLA, too, serving as RAISON chair, Conference Chair, Programming Chair (several times), and currently, as the Exhibits Chair for the upcoming Nevada Library Association Conference.

John Crockett never expected to become a librarian, much less the Internet Services librarian for Washoe County Libraries. With a degree in environmental science and a much greater interest in skiing, John moved west to Lake Tahoe, where one year followed another, filled with a variety of jobs. When the new library opened at Incline Village, he applied for a job... and the doors opened on a new career. He went from temporary worker to part-time aide to full-time children's librarian within a year, meanwhile maintaining his life on the ski slopes (and even skiing to work). After completing the coursework for an MLIS through the University of Texas, John moved to Reno and was promoted to his current position. He is also president-elect of the Nevada Library Association.



Nevada can be proud of its two candidates to the 2012 Leadership Institute, and I have every confidence that they will return to Nevada and to their respective positions with a wealth of knowledge, understanding, and expertise, enriching not only their own experience but that of everyone around them.

Early on, SLIS recognized the benefits of delivering its courses online, including introducing students to the emerging technology they'll encounter when working in the rapidly changing LIS field. As they interact with peers and faculty from a distance, SLIS students



are immersed in sophisticated technology, preparing them to serve clients and collaborate with colleagues who live across town or around the globe.

"We know that tomorrow's information professionals will need to interact with virtual teams and use emerging technology to serve clients," said Debbie Faires, SLIS assistant director for distance learning.

"We're excited about providing students with skills that will make them more employable in today's challenging economic climate."

Technology has opened up a world of opportunities for SLIS students. They present at virtual conferences and participate in research projects, all without leaving their homes. They gain hands-on experience as virtual interns, interacting with host institutions that may be located anywhere on the continent. For example, a student who lives in Nevada may intern at a high-tech Silicon Valley company without traveling to California.

The San José State University School of Library and Information Science offers two fully online master's degrees, a fully online certificate program, and a doctoral program: Master of Library and Information Science (MLIS), Master of Archives and Records Administration (MARA), Post-Master's Certificate in Library and Information Science, and the San José Gateway PhD Program.
